Scientific Area: Anthropology and/or History

Admission criteria: students must be enrolled (or in condition to be enrolled) in an undergraduate course, integrated master, master or enrolled in courses that do not confer an academic degree in Anthropology and/or History, as per articles 5.º and 6.º from Regulamento de Bolsas de Investigação da FCT, I.P..

Candidates that have already benefited from research grants (regardless of the typology), directly or indirectly financed by FCT, are not eligible.

Work plan

BII_Blog Antropia

The fellow will produce new digital content related to climate change and health in Lusophony, with special attention to African contexts, thus contributing to the different sections of the Antropia Blog. The work plan will take place at CRIA-UC.

BII_Coeso

The work plan includes archival research on the history of the streets of Santa Marta and São José in Lisbon, reconstructing for example the evolution of the occupation of some buildings in the last decades (building biography), and collaboration for the editing of the Blogue Cidade (In)visível. Tourism and other daily practices in Lisbon.

BII_LAV (AudioVisual Laboratory): Editing of 2 e-books resulting from training activities carried out at the Laboratory in the last 3 years.

Work place: the work plans will be developed at CRIA, under scientific supervision of Doctor Jorge Varanda (BII_Blogue Antropia), Doctor Frédéric Vidal (BII_Coeso) and Doctor Filipe Reis (BII_LAV).

Duration of the fellowship(s): The fellowship will last for one month, non-renewable, starting on September 1st 2022.

Monthly maintenance allowance: The amount corresponds to €486,12, according to the Table of Allowances for Grants approved under FCT Regulation No. 950/2019, of 16 December.

Selection method: The selection process is based on the curricular path evaluation (70%) and motivation letter assessment (30%). The jury reserves the right not to award the fellowships if applicants' profile is not aligned with the fellowships' work plans.

Selection panel: Doutor Jorge Varanda (Presidente); Vogais: Doutor Frédéric Vidal e Doutor Filipe Reis.

Application submission and deadline: The call is open from July 14th to 27th, 2022.

Applications must be submitted at CRIA's website: <https://cria.org.pt/pt/emprego-e-bolsas>, accompanied by the following documentation:

A motivation letter (indicating the preferred scholarship: Blogue Antropia, Coeso or LAV).

Curriculum Vitae.

Qualification certificate(s) including a breakdown of the marks obtained in the disciplines of the respective course and final classification (if applicable).

Proof of enrolment in study cycles conferring or not conferring a degree (Although the applicants must be enrolled in a cycle of studies leading to the attribution of an academic degree or courses that do not confer an academic degree, at the time of application it is not necessary for the applicants to have made such an enrollment.)

Applications sent through any other means will not be considered.

Results notification: All candidates will be notified of the selection process by email.

The presentation of all documents is mandatory for signing of the fellowship contract, including proof(s) of academic degree(s) and/or proof of enrolment in a course not conferring a degree and/or recognition of academic degree obtained abroad.

Academic degrees obtained abroad require recognition by a Portuguese Institution according to Decree Law no. 66/2018, of August 16 and Ordinance no. 33/2019, of January 25.

Under the terms of D.L. No. 29/2001, of February 3rd, a candidate with disability has priority in case of equal classification, which outweighs any other legal priority. Candidates shall provide a sworn statement, in the application form, declaring their respective degree of disability, type of disability and the forms of communication/expression to be resorted to in the selection process, under the terms of the aforementioned decree.
