Scientific Domain: Anthropology

# Admission Requirements General:

Candidates should hold a bachelor degree in Anthropology, History, Sociology or related areas and be enrolled in a Master's in a related area or non-degree courses (according to Article 6 of the current Regulations for Research Grants of the Foundation for Science and Technology, I.P.).

Candidates should understand French (written and spoken)

### Desirable:

- Experience on academic work, demonstrating the ability to collect, organise and interpret information within the framework of a specific field of study.
- Experience in digital media.
- Experience in image processing.

# Work Plan

The selected candidate must carry out the following tasks associated with the exploratory research project "Things from Portugal: identity negotiations and uses of Portuguese material culture in the context of transnational migration". Information on the project is available <u>here</u>

- Online mapping of the shops in Paris that sell so-called Portuguese products; identify the products sold; identify the artisans and designers who produce them; organise, process (for later use) and archive the information collected.
- Make a brief interpretation of the narratives associated with the shops and the objects.
- Identify registered producers with the Portuguese-French Chamber of Commerce and Industry and AICEP.

**Applicable legislation and regulations:** Research Grant Holder Statute, approved by Law no. 40/2004 of 18<sup>th</sup> August, in its current wording published by Decree-Law no. 123/2019 of 28<sup>th</sup> August; Research Grant regulations of the Foundation for Science and Technology, I.P. – in force and available at:

**Workplace:** The workplace is located at CRIA NOVA FCSH and/or other places necessary for the development of research activities

**Duration of the scholarship:** The scholarship is for a period of 3 months (non renewable), scheduled to begin on 1<sup>st</sup> December 2023.







**Amount of the monthly maintenance allowance:** The amount corresponds to € 930,98 € according to Annex I – Table of monthly maintenance allowances of the FCT Research Grants Regulations in force. The grant will be paid monthly by bank transfer.

### Selection methods:

- (1) Curriculum Vitae Evaluation (60%). To be considered:
  - a. The preferential factors for admission to the competition
- (2) Motivation Letter Evaluation (40%). To be considered:
  - a. Well-articulated reason for interest in the position
  - b. Convincing proposal for why the candidate should be chosen

Candidates will be classified and ranked, according to the previous criteria, on a scale of 0 to 100.

In case of a tie, the score of the Motivation Letter Evaluation will prevail.

The jury reserves the right not to award a scholarship if no candidate meets the required profile.

**Application deadline:** The call is open from November 6<sup>th</sup> to November 17<sup>th</sup>, 2023

**Application submission**: Applications, in Portuguese or French, must be submitted on the CRIA website, at <a href="https://cria.org.pt/en/jobs-scholarships">https://cria.org.pt/en/jobs-scholarships</a> accompanied by the following documentation:

- Motivation Letter
- Curriculum Vitae
- Certificates of academic qualifications, specifying the final classification and, if possible, the marks obtained in all the subjects taken
- Proof of enrollment in a Master's programme or course not conferring an academic degree
- Document certifying knowledge of written and spoken French

Applications submitted by other means will not be considered. Candidates who formalise their application incorrectly or who do not prove the requirements will be excluded from admission







to the competition. In case of doubt, the selection board may require any candidate to produce documents to support their statements.

\* Academic degrees obtained abroad require recognition by a Portuguese Institution according to <u>Decree Law no. 66/2018</u> of 16<sup>th</sup> August and <u>Ordinance no. 33/2019</u>, of 25<sup>th</sup> January. The presentation of the recognition is mandatory for the signing of the contract.
